## **Notice of Nomination for Election**

### Explanatory Memorandum

This Notice was initially given on 15 February 2025, which was at least 42 days before the Annual General Meeting, to be held on 17 May 2025.

All nominations to be elected to the Management Committee must be received by the Secretary, at info@auzmbc.com.au, no later than 8 March 2025 which is 28 days before the Annual General Meeting.

The nominee may nominate for one specified position of office holder of AZBC or to be an ordinary committee member. However, a person must not hold 2 or more of the offices mentioned above.

All nominees must be:

- ordinary members; and
- at least 18 years old.

The following persons cannot be elected to the Management Committee without leave of the Commissioner:

- a bankrupt or person whose affairs are under insolvency laws;
- a person convicted, within or outside the State, of:
- an indictable offence in relation to the promotion, formation or management of a body corporate; or
- an offence involving fraud or dishonesty punishable by imprisonment for a period of not less than 3 months; or
- an offence under Division 3 or section 127 of the Associations Incorporation Act 2015 (WA).

At the Annual General Meeting a separate election will be held for each position.

If there is no nomination for a position, the Chairperson of the meeting may call for nominations from the ordinary members at the meeting.

If only one member has nominated for a position, the Chairperson of the meeting must declare the Member elected to the position.
